Refund policy: Rescue agrees to allow Adopter to adopt Dog listed above under the terms in this
contract. 50% of the donation is refundable upon request provided the adopter returns a dog to the rescue
within seven days of adoption. The dog must be returned with all records and adoption folder or no refund
will be issued. Upon return the adopter releases rescue of any and all liability. Refund check checks can
take four weeks for issuance.

Important note there is no refund for dogs returned after the seven day time period.
Trial adoptions (only fill out if approved by adoption team) - only trial adoptions complete herein:
 Rescue may allow a trial adoption, where Adopter will receive a refund a full donation upon
request, provided the Adopter agrees to the following terms: A) Adopter will personally return the
dog to rescue within 14 days of adoption if they do not wish to complete adoption. B) Adoption
folder and records will be returned with the dog and C) Adopter releases rescue of any and all
liability. Adoption checks will be deposited and the refund can take four weeks for issuance
 Adopter will contact the rescue with any health or behavioral questions. During a trial adoption,
Adopter understands they may must receive explicit prior approval for vetting reimbursement with
a specific approved rescue partner veterinarian.

Terms and conditions of the Pokie & Friends Adoption agreement

- 1. This dog shall not be sold rehomed given or surrendered to any other party entity business or animal rescue or shelter without the expressed written consent of this rescue
- 2. Due to the high volume of pets without a home, we are very serious about all pups being spayed/neutered (if they haven't yet been by the date of adoption) around 6 months of age. You may go through our rescue for this, or can provide proof of sterilization from your veterinarian. Not spaying/neutering is taken very seriously and will be considered a violation of the adoption agreement and the dog may need to be returned. Please set a reminder in your phone to send us the update or paperwork.
- 3. If Adopter is unable or unwilling to care for the dog, Adopter will notify the rescue immediately. Adopter shall provide care for Dog as per the terms of this agreement for up to 14 days following the notification to the rescue.
 - a. Adopter understands at this time is necessary to allow the rescue to find a foster home.
 - b. Adopter shall transport dog to Rescue's principles place of business or a location within California that is designated by Rescue at Adopter's own expense. Adopter shall provide veterinary records (including those given an adoption, and vet records after adoption), tags, microchip info and shall provide photos and requested information to assist Rescue in rehoming.
- 4. The dog shelters like **inside the adopter's home** and live as a family member. The dogs will not be left alone outdoors while Adopter is not at home and should be kept under Adopters control while outdoors, and shall not roam freely outside of the fence yard or a dog park without proper training and supervision.
- 5. The dog should not be crated longer than eight hours. Puppies and small dogs have small bladders and should not be crated for more than four hours at a time. The crate must large be large enough for the dog to turn around and lay comfortably.
- 6. The dog will not be left in a vehicle unattended for extended periods of time.
- 7. Adopter shall provide adequate quality food, water, shelter, grooming, and exercise and shall care for the dog in a devoted and humane manner for the remainder of the dogs natural life.
- 8. **Children supervision -** This rescue does not recommend that the dog be left alone with small children for any length of time. Adopter understands a dog cannot be left alone with children they are not familiar with without proper supervision and that you put children and the dog at risk without supervision.
- 9. The dog should be seen by a licensed veterinarian within 10 days of adoption and at least once per year thereafter. Adopter will maintain appropriate vaccinations and preventative healthcare. Dog shall be kept on heartworm and flea/tick preventative. Unless directed by veterinarian, cosmetic surgery will not be performed including tail docking or ear cropping.
- 10. Most times, the rescue has little knowledge of the dog including a specific breed, age, medical conditions and disposition temperament. The rescue makes no guarantees with regard to the exact breed of the dog and we base our breed listing on available information. Rescue makes no guarantees about the health or temperament of a dog and disclaims any liability for the dogs temperament or medical condition, sickness or disease. Adopter understands the dog may have a virus condition, health effect or illness that was not detected by a veterinarian, by the rescue, or via foster, and was unknown at the time of adoption. Any available information rescue has will be disclosed to Adopter. Adopter will immediately contact Rescue if issue arises within 10 days of adoption. Adopter has received copies of test results, vaccines and spay/neuter information.

- 11. Rescue reserves the right to inspect the dog if alerted that Adopter may be violating this agreement.
- 12. Upon adoption of the dog, Adopter releases rescue from any of the claims and actions whether for property damage caused by the dog(s) or for personal injury to any human or other animal personal dogs or livestock from biting, scratching, transmittal of disease, and/or any matter attributable to the dog(s).
- 13. Rescue shall, for the purpose of assuring the dogs well-being after being notified that the dogs health and/or well-being are in jeopardy, exercise its right to take the dog through a claim and delivery proceeding. Should it become necessary for Rescue to take legal action to recover the dog, or enforce this agreement and spay/neuter agreement the doctor is responsible for all court cost and attorney fees incurred by either the Adopter or Rescue, as well as cost incurred by Rescue to recover the dog and necessary care to restore dogs health
- 14. **Rescue's right to terminate agreement** if agreement terms or spay/neuter agreement are not upheld by Adopter, Rescue reserves the right to terminate this agreement and Adopter agrees to allow a rescue representative to reclaim the dog without receipt of any refund for adoption donation
- 15. If the dog becomes lost, seriously injured, or dies Rescue shall be notified within five business days. We will do our best to help you find your dog.
- 16. Adopter authorizes any animal care and control agency to release the dog to rescue here by designated as agent for Adopter, if dog is found running at large or is brought into a sheltering facility for any reason.
- 17. If Adopter surrenders a dog at a sheltering facility or Humane Society without prior approval from Pokie & Friends, Adopter agrees to pay Rescue a \$500 penalty and all court cost incurred by the Rescue to claim such a penalty from Adopter.
- 18. Dog shall wear a humane collar and display identification tags
- 19. For one year following adoption, Adopter shall notify Rescue of any changes in address or email
