

# Pokie & Friends Foster Care Agreement

The Foster Family agrees to foster the following animal (hereinafter called, "Animal") from **Pokie & Friends Rescue**.

As a Foster Family, I/We agree to the following:

1. I/We understand the animal is currently named \_\_\_\_\_, and it is necessary for record keeping, appointments, public information, etc. to refer to the animal by this name.
2. To allow a representative of Pokie & Friends to visit my premises to insure the terms of this agreement have been kept.
3. The Animal will be provided with adequate fresh food and water, clean, dry shelter when outside, and daily exercise.
4. To provide a safe collar with rabies and I.D. tags to be worn at all times (when applicable).
5. To obey all applicable laws governing control and custody of animals.
6. To foster the Animal as a family companion only.
7. If fostering a dog, the dog is not to ride loose in the bed of pickup trucks, convertibles or to be left in a car when air temperatures exceed 70 degrees Fahrenheit.
8. If fostering a dog, the Foster Family agrees to have a clean, secure fenced area for the dog. If a fenced enclosure is not available, the Foster Family agrees to walk the dog on a leash.
9. Foster Family agrees to bring the animal to veterinary appointments or allow for Pokie & Friends to make arrangements to make alternative transportation to get the animal to the appropriate appointments/events.
10. Foster Family understands that Pokie & Friends retains legal control of the animal and is not authorized to make any legal or medical decisions on his/her behalf.
11. Foster Family agrees to allow potential adopters that Pokie & Friends has approved to meet the foster dog at the family home OR at another reasonable location.
12. Foster Family agrees to facilitate meetings with prospective adopters and answer questions by potential adopters.
13. Foster Family agrees to respond to Pokie & Friends within 24 hours concerning the animal and/or potential adopters.
14. Pokie & Friends makes no guarantees regarding the dog's age, breed, health, or temperament.

While Pokie & Friends has made every effort to provide accurate history and assessment of the dog, the rescue is not able to guarantee the dog's age, breed, medical status, behavior or disposition. However, Pokie & Friends is available for consultation, advice and assistance pertaining to the health, training and compatibility of the dog.

15. All medical expenses that are approved by the Pokie & Friends Board and treated through Pokie & Friends approved veterinary office will be covered by Pokie & Friends. **If you take our dog to your vet it will not be covered.**
16. Foster agrees to release Pokie & Friends and its members or representatives of any and all possible claims arising from injury or damage caused by the animal to any person or property.
17. If you choose to adopt your foster animal. You will be required to fill out an adoption application. Upon receipt it will be processed to Pokie & Friends guidelines.

As a Foster Family, I/We agree to release the previous owner as well as Pokie & Friends Rescue and its representatives of any liability arising from our duties as a Foster Family, from this date forward.

**I/we agree to abide by the foster conditions and I/we have read and fully understand that Pokie & Friends Rescue may repossess this animal at any time if the foster conditions are violated or the animal is mistreated.**
